

## SCCI Financial Forecast

At Soul Care Consulting International, we believe that financial stewardship is an integral part of our ministry's integrity and witness. Our commitment to financial transparency and responsible fundraising reflects our dedication to biblical principles and the trust our partners place in us. This philosophy is rooted in our belief that all resources, whether financial or otherwise, are entrusted to us by God for His glory and service.

## Core Principles of Financial Transparency and Fundraising

- **Integrity in Stewardship:** We are committed to managing funds with the utmost integrity, ensuring that all financial practices are honest and aligned with biblical teachings. "The Lord detests dishonest scales, but accurate weights find favor with him" (Proverbs 11:1). Our goal is to achieve 100% compliance with ethical financial practices, conduct bi-annual reviews, and ensure all financial transactions are well documented.
- **Trust and Accountability:** Financial records and practices are accessible to stakeholders to foster trust and accountability. We aim to provide clear, detailed financial reports and annual statements within 30 days of the fiscal year's end. "Better a little with righteousness than much gain with injustice" (Proverbs 16:8). Our objective is to build transparency by hosting quarterly updates and feedback sessions with partners.
- **Partnership and Purpose:** Our fundraising approach emphasizes building authentic, purpose-driven partnerships. We invite supporters to be part of our mission, not just as financial donors, but as participants in the transformative work we do. We strive to increase our giving partners 20% annually, ensuring that each partner feels valued and connected. "Each of you should give what you have decided in your heart to give, not reluctantly or under compulsion, for God loves a cheerful giver" (2 Corinthians 9:7).
- **Transparency in Communication:** We communicate openly about how funds are allocated and spent, ensuring donors and partners understand their impact. Our goal is to provide monthly newsletters and quarterly impact reports that highlight project outcomes and financial use. By sharing stories and data that reflect the ministry's work, we reinforce mutual trust and stewardship. "So whether you eat or drink or whatever you do, do it all for the glory of God" (1 Corinthians 10:31).
- **Ethical and Responsible Practices:** We commit to ethical fundraising practices that respect the dignity and well-being of our partners and the broader community. Our fundraising strategies aim to maintain a financial donor & ministry partnership retention rate of 90% and promote engagement without pressure. "Do not take advantage of each other, but fear your God. I am the Lord your God" (Leviticus 25:17). We will evaluate fundraising tactics annually to ensure they align with our core values and biblical principles.
